## FACULTY OF ECONOMIC AND MANAGEMENT SCIENCES - SECOND SEMESTER EMERGENCY REMOTE TEACHING PLAN

MOTIVATION: The Minister of Higher Education advised that at most one-third of students across the university are permitted to return under Level 3. In addition, students who need to complete practical or clinical work and students whose current living circumstances are not conducive to online learning were given priority. Social distancing regulations also require that we can only accommodate a maximum of 50 students at a time in a 300-capacity lecture hall - which caused an unresolvable situation around physical space and roster scheduling. Our understanding is that this restriction of 50 per venue is intended to remain in place even under Levels 2 and 1. Due to the realities of the COVID-19 pandemic and the uncertainty of the timelines it was decided to give more certainty and clarity to students to plan for the second semester, and thus to communicate that the following modules will remain emergeny remote teaching for the remainder of the semester. Be assured that even if the situation changes and we are able to bring more students back onto campus at a later date in the year, it will be possible for you to continue with remote learning even if you are unable to return to campus. Students that are unable to return to campus for invigilated examinations e.g. international students, will be required to sit for the examination and special arrangements will be made.
