Nomination of a member of the Electoral College of Donors to serve on SU Council for a four-year term.

We call on all members of the Electoral College of Donors to participate in the election to fill the vacancy of a donor to serve on the SU Council. Members of the Electoral College of Donors of Stellenbosch University are hereby informed that, in terms of parr 6(l) and 9(2) of the SU Statute, an election must be held to appoint a member of the Electoral College of Donors on Council. Mr Jannie Durand completed three terms on Council and is no longer eligible for consideration. The other two members of the Electoral College of Donors serving on Council are Ms Nicky Newton-King and Ms Helena Conradie.

Written nominations by members of the Electoral College of Donors to fill this vacancy will be awaited by the Registrar until **12 October 2024 at 23:59 (SAST)**. Each nomination must be signed by at least five donors (apart from the nominee themselves) and must be submitted under the signature of the nominee to indicate that they accept the nomination. The nominations must be submitted on the prescribed nomination form and must include a vision statement of no more than 100 words. The inclusion of a CV is optional. Nominations must be submitted via e-mail to elections@sun.ac.za by the due date. The nomination form is available [here](#).

In pursuance of clause 7 of the Statute, the following requirements for nominees apply:

- A candidate must be a person with knowledge and experience relevant to the objects and governance of the University;
- A candidate may not already serve in another capacity on the Council;
- A candidate may not be 70 years or older on 15 November 2024
- A candidate may not be an employee of, or student at SU; and
- No candidate may be a member of the Council of another institution of higher learning or be employed in a permanent executive managerial capacity at the level of, or equivalent to, a dean or higher by such an institution.

The onus is on the proposer, seconders and the nominee to ensure that the nomination is valid and aligned with the SU Statute, and that due consideration is given to representation with regard to race, gender and disability.

Mnr Jannie Durand het drie termyne in die Raad gedien as verteenwoordiger van die Kieskollege van Donateurs en kan nie verder oorweeg word nie. Die ander twee lede wat die Kieskollege van Donateurs verteenwoordig in die Raad is me Nicky Newton-King en me Helena Conradie.

Skriftelike nominasies deur lede van die kieskollege word deur ondergetekende ingewag tot **12 Oktober 2024 om 23:50 (SAST)**. Elke nominasie moet deur minstens vyf donateurs (buiten die genomineerde self) onderteken wees en moet onder die handtekening van die genomineerde dat hy/sy die nominasie aanvaar, per e-pos by verkiesings@sun.ac.za teen die sperdatum ingedien word. Die nominasie moet op die voorgeskrewe nominasievorm ingedien word en moet 'n visiestelling van maksimum 100 woorde insluit. Die indiening van 'n CV is opsioneel. Die nominasievorm is [hier](#) beskikbaar.

Ingevolge klousule 7 van die US Statuut, geld die volgende vereistes:

- 'n Kandidaat moet 'n persoon met kennis en ervaring relevant tot die doelwitte en oorsigbestuur van die Universiteit wees;
- Kandidate mag nie reeds in 'n ander hoedanigheid in die Raad dien nie;
- Kandidate mag op 15 November 2024 nog nie 70 jaar oud of ouer wees nie;
- Kandidate mag nie werknemers van, of studente aan die Universiteit wees nie; en
- Geen kandidaat mag lid van die Raad van 'n ander hoërondewysinstelling wees, of van die permanente uitvoerende bestuur op die vlak van, of ekwivalent aan, 'n dekaan of hoër, nie.

Die onus is op die voorsteller, sekondante en genomineerde om te verseker dat nominasie geldig is en aan die vereistes in die Statuut voldoen, en dat daar

behoorlik oorweging geskenk word aan verteenwoordiging met inagneming van ras, gender en gestremdheid.
