The Programme in Managing Food Security as a development opportunity

The management of food security provides a growing opportunity for producers, those involved in post-harvest processes throughout the different supply chains, and retailers.

For those working across the food system,

it is a huge challenge to ensure enough safe, nutritious and culturally appropriate food. Addressing the challenges of the food system requires producers, managers, retailers, supply chain managers and policy makers to understand the changing context of the food system. Understanding the context will result in people across the system reducing waste and losses and ensuring that more efficient, safe and nutritious food is available. Failure to understand the system results in inefficiency, waste, poor service delivery, unsafe and even insufficient food.

Managing food security needs to be addressed and managed within the framework of sustainable development. There is a critical knowledge and skills gap in understanding the various food system pressures, such as land reform, governance, production and consumption trends, climate change, state interventions and the availability of affordable safe, nutritious food to those who are food insecure. Understanding the food system challenges enables people to undertake accurate scenario planning and to better manage the diverse set of risks. This will result in adaptation and change management plans.

USB-ED, in collaboration with the University of Stellenbosch Food Security Initiative, developed the Programme in Managing Food Security in recognition of this critical knowledge and skills gap. This programme is a first for Africa, providing participants with a learning experience that will translate into action plans in the work environment.

Programme in Managing Food Security

Who should attend?

You will benefit from this programme if you are a supply chain or procurement director; or a value chain manager, commercial manager, sustainability manager, strategy manager, risk manager, retailer, risk auditor, agri-processing manager, consumer goods manager; or a government official without training in food security risk and scenario management.

What does it cover?

The programme will include the following modules:

- Food security in southern Africa – the context of production, land, processing and distribution
- Systems thinking and organisational change
- Futures thinking and scenario planning
- Sustainable competitiveness

What is your return on investment?

This programme will investigate the main issues relating to food security management, both theoretically and practically. However, the emphasis throughout the programme will be on practical application in a real-world setting and the use of case studies as a learning approach. After completing the programme, successful participants will be equipped to:

- Analyse risks in their environment and identify strategies to reduce risks and reduce losses
- Develop plans of action to address food security challenges, with specific reference to their area in the food system
- Debate and discuss food supply chain issues such as land and resource challenges, the maintenance of cold chains and financing of supply chains, as well as opportunities to improve food systems in Africa
- Identify opportunities for change in the food system
- Construct scenarios as part of decision making that will result in developing and growing businesses in changing economic, political and climatic conditions; and
- Address sustainable development as a business case in their own particular environment.

The programme will also provide the necessary foundation for individuals who wish to prepare themselves for further studies in Food Security at a later stage in their careers.

What will be required of you?

You will be required to attend one classroom-based study block of four days from 08:15 – 17:30. Participants will be expected to prepare prior to the study school through pre-reading as well as pre-course assessments. Individual assignments need to be completed after the study school and must be submitted a month after the conclusion of the programme.

NQF alignment

The scope and presentation of this programme is aligned with the National Qualifications Framework (NQF) Level 7.

Admission requirements

No formal tertiary qualifications are required. Participants should have English language competence at NQF level 4 or equivalent, and sufficient ability to comprehend learning material, write assignments and follow/participate in discussions on issues in the development area.

Certificate

On successful completion of the programme (which includes attending the classroom-based study block as well as passing the assignment), you will receive a certificate of competence from Stellenbosch University.
