Language Implementation Plan for 2025¹ (LIP)

19 March 2025

1) Introduction

The language plan of the Faculty of Economic and Management Sciences (EMS) is aimed at implementing the revised language policy that was approved by Council and Senate on 2 December 2021. The context in which this implementation occurs, is that of a large faculty with diverse undergraduate and postgraduate programmes and students. It follows the significant evolution of the Faculty's language offering over the past few years to increase access while maintaining a multilingual offering. EMS views multilingualism as an important professional asset for students and a resource in South Africa.

For the purposes of LIP 2025, a questionnaire was sent to all undergraduate module coordinators to obtain their input (taking into consideration the student feedback they had received during 2024, projected student numbers, pedagogical approaches, staff availability and projected work allocation for 2025). Student input was attained by means of module feedback and feedback received via formal channels. All feedback has been collated in this report.

2) Aims of the LIP and multilingualism

The principal aim of the LIP is to contribute to the SU Vision 2040 and Strategic Framework 2019–2024. Given the learning-centred approach to teaching and learning in the Faculty, the language plan must address the needs and language preferences of the Faculty's students. By doing so, the LIP facilitates the attainment of the core strategic themes, especially (1) a transformative student experience and (2) networked and collaborative teaching and learning.

The LIP specifies the language of delivery in formal lectures and learning material. However, this is only one component of the learning-centred approach to learning and teaching. The Faculty traditionally uses various supplementary facilitated learning opportunities, e.g.

extensive tutorials and informal peer-mentorship opportunities for contact beyond formal lectures. These present an opportunity to promote multilingualism.

Most tutorials and practical's are offered in double medium (where both Afrikaans and English are used in the same lecture). Lecturers and/or tutors are available to assist students in their language of preference.

One-on-one conversations are held in students' language of preference as much as possible. Lecturers are making a concerted effort to learn isiXhosa to be able to engage with students in their home language, albeit on a basic level. Generative AI tools are also used to assist in communicating with students in their preferred language.

Various modules use Mobilex or other glossaries to assist students in their learning (e.g. Statistics 214, Introduction to Economics 141 and Financial Accounting 178). Peer-to-peer learning is also used to promote multilingualism during interactive lectures, group work for assessments and tutorials/practicals.

Over and above the more informal facilitated learning opportunities, some modules have purposefully chosen double medium as language specification to attain specific pedagogic objectives (e.g. a diversity of viewpoints) that could also serve to develop multilingualism.

3) Language use in Teaching and Learning

The language specification for each of the Faculty's modules for 2025 is stipulated in Annexure A with the following options used per year group for full-contact modules:

The Faculty will continue to offer undergraduate B-degrees and undergraduate diploma programmes in the following language options: separate lectures in Afrikaans and in English (A/E or parallel medium, 7.1.3 in the SU language policy); both Afrikaans and English are used in the same lecture (A&E or double medium, 7.1.4 in the SU language policy); or, in exceptional cases, some modules are presented in one language only (A|E|X or single medium, 7.1.5 in the SU language policy), in which case simultaneous interpreting is provided as and when required and feasible.

At the School of Public Leadership (SPL), all undergraduate diploma programme modules will continue to be offered in single medium (English). This has been necessitated by the student profile, mode of delivery (including hybrid mode), and student numbers. Both the (undergraduate) Diploma in Sustainable Development and the Advanced Diploma in Sustainable Development rely heavily on experiential learning, therefore the pedagogical approach does not lend itself to simultaneous interpreting, e.g. sessions are presented at relevant learning sites in the open, and sessions include practical learning, group work, field trips, etc. In the case of both these programmes, in-person teaching does not refer to traditional lectures.

The programmes have relatively small student numbers and consist of students from diverse cultures, languages and backgrounds. The facilitators of the programmes are mostly ad hoc non-university staff who are neither fluent in Afrikaans nor isiXhosa, therefore unable to teach in either language.

Although it is indicated that these modules are presented in single medium (English), multilingualism still has a place in these programmes, e.g. students use their preferred language in small groups to workshop ideas. Where possible, facilitators converse with small groups in languages other than English. Because of the nature of the sessions and the methods employed, students help one another when they have difficulty expressing themselves in English. The development of students' communication skills is supported within the programme irrespective of their first language, e.g. through initiatives such as scheduled sessions at the Writing Lab, the ReadTheory programme (to support students' ability to read with comprehension) and Strategic Communication modules.

Both the Diploma in Public Accountability and the Advanced Diploma in Public Accountability has a very specific target market (municipal workers). In this case English is seen as a universal professional language and therefore the chosen language of instruction.

3.1. Changes to the language specification of undergraduate modules in 2025

The Faculty has experienced consecutive years of high first-year enrolment rates that lead to more class groups and venue capacity constraints. At the same time staff has reported very low attendance of students in Afrikaans groups. To utilise venues optimally and take into consideration the available staff and their language proficiency, changes have been made to the language specification of modules offered by the Faculty, especially in the Department of Business Management Department of Industrial Psychology and the School of Accountancy. New modules will also be implemented in 2025.

The following changes were made for 2025:

- In the **Department of Business Management**:
 - There has been a significant drop in the interest of Afrikaans lectures and tutorials. In most cases no students come to the Afrikaans tutorials and one to 20 students attend the Afrikaans lectures. This leads to a misuse of resources that can be better applied in other large groups where constraints exist. In the past all modules presented by the Department of Business Management were presented in parallel medium. However, as per the Stellenbosch Language Policy all first-year modules continue to be presented in parallel medium. Second-year and third-year modules will be presented in double medium or single medium from 2025.
- A deviation from the language policy was approved for 2025. Entrepreneurship and Innovation Management 214, Marketing Management 214, Marketing Management 244 and Financial Management 332 were indicated on the 2024 LIP as double medium. However, due to staff capacity and staff's language proficiency, these modules will be presented in single medium (English) with simultaneous interpreting in 2025 (tabled and approved at the Faculty Board meeting on 28 February 2025). In the **Department of Industrial Psychology** a deviation from the language policy was approved for 2024. Industrial Psychology 224, 252 and 262 were indicated on the 2024

LIP as parallel medium. However, due to limited staff capacity, staff's language proficiency and small Afrikaans groups (12 – 50 Afrikaans students vs 230 – 270 English students) and low attendance in Afrikaans groups (2 – 5 students per lecture), these modules were presented in single medium (English) with simultaneous interpreting in 2024 (tabled and approved at the Faculty Board meeting on 1 March 2024). The Department also has a small staff complement and relies on contracted lecturers. As the circumstances will remain the same in 2025, this deviation will be integrated into the 2025 LIP. It is not financially viable to continue presenting these modules in parallel medium for the small number of students.

- In the **Department of Statistics and Actuarial Science**:

- Financial Risk Management 314 has been presented in double medium in 2024 and will be presented in single medium in 2025. The Department is honoured to have an award-winning expert in the field as lecturer for the module. The lecturer is not proficient in Afrikaans.
- In the 2024 LIP Statistics and Data Science 188 was indicated as parallel medium with the practicals offered in double medium. However, due to the nature of the module (specifically the Data Science section) and staff limitations, the entire module was offered in double medium (the deviation had been tabled at the Faculty Board meeting of 1 March 2024). This altered language specification will be continued in 2025 due to the limited number of computer user areas and the large number of students enrolled for this module. The timetable simply does not allow for separate Afrikaans and English practicals and staff availability does not allow for separate Afrikaans and English venues.

- In the **School of Accountancy**:

- Due to unforeseen limited staff capacity (one of the staff members assigned to the relevant modules is on extended sick leave), the remaining staff members' language proficiency and the nature of the subject module (software, AI, digital skills and subject nomenclature that is only available in English), the Digital- and Leadership Acumen for Accountants modules' language specifications for 2024 deviated from the approved 2024 LIP (as tabled at the Faculty Board of 1 March 2024) and will continue to be implemented as such in 2025:

The theory-based first-year, first-semester module Digital- and Leadership Acumen 112 that was indicated as parallel medium in the 2024 LIP will be presented as double medium in 2025 (as it was in 2024 with the approved deviation). The module will have simultaneous interpreting available to students during lectures.

Digital- and Leadership Acumen 122, 142, 152, 162, 212, 245, 312 and 253 will be presented in single medium (English) in 2025. These modules utilise a blended format more appropriate to the module content taught in these modules. Students are supported individually in English or Afrikaans (where possible) during the in-person practical classes facilitated by lecturers and class assistants. All main assessment opportunities are available in Afrikaans and English.

- Though Auditing 288 and 388; Business Ethics 214; Financial Accounting 278, 288, and 389; Management Accounting 278 and 288 and Taxation 298 have been presented in parallel medium, it will be changed to single medium (English) with simultaneous interpreting to Afrikaans from 2025. The number

of students registered for these modules necessitates the modules to be presented in groups. While the Afrikaans groups are extremely small (less than 10 students attend each group), the English groups are too large to allow for active participation by students. This also puts pressure on the lecturers teaching the English groups in terms of one-on-one consultations. The Afrikaans groups will therefore become English groups with simultaneous interpreting to Afrikaans.

From 2025 the following new modules will be presented in the Faculty:

- Digital- and Leadership Acumen for Accountants 246 will be presented in single medium. This module replaces Digital- and Leadership Acument 242. Portfolio of Evidence: Accountancy 345 will be presented in single medium (English). These changes have been made as part of the School of Accountancy's academic renewal in line with the South African Institute for Chartered Accountants' (SAICA) *Chartered Accountant of the Future CA2025* project.
- Entrepreneurship Incubator and Social Entrepreneurship replaces Entrepreneurship Incubator 151 in the Advanced Diploma in Sustainable Development. This has been done as a renewal of the advanced diploma after the first iteration. This allows for better flexibility for students and can increase the throughput for these learn-and-earn students. Both new modules will be presented in single medium as part of the hybrid programme.

4) Language in administration and management

Decisions regarding the language of administration and management will be aimed at enhancing comprehension and inclusivity. In general, formal communication for administrative purposes includes both Afrikaans and English, with the implication that all official written documentation will be in Afrikaans and English. Communication with current and prospective students will be in either Afrikaans or English, depending on the language preference of the student. At postgraduate level, however, communication will be mainly in English, but will also reflect the language of tuition employed by the respective departments.

The language of e-mail communication among staff members is not prescribed. However, all attempts are made to communicate in the language that is understood by all recipients. This reduces the time cost of translating e-mails. In meetings, the context of the meeting and participants will determine the language of communication.

5) Feedback mechanisms on implementation

Students and staff may give feedback regarding the implementation of the language plan via the Faculty's existing student structures, namely the Economic and Management Sciences Student Committee (EMSC/"EBSK") and class representatives, as well as the faculty committee. Students also use the existing module feedback mechanisms. However, we find that students often give language feedback directly to a lecturer or the departmental chair, and that they only use formal mechanisms when issues are not resolved.

6) Conclusion

The Language Implementation Plan for 2025 serves the SU Vision 2040 and Strategic Framework 2019 – 2024. Unforeseen deviations from this plan will be submitted in accordance with the Language Policy of the University.

Simultaneous interpreting will be made available should the need of the students warrant the service and the University has the resources to provide it. If two weeks have passed with no students making use of the interpreting service in the module, it will be discontinued.

* Flipped classroom does not allow for simultaneous interpreting. However, students are free to create/join groups to work in, often according to their language preference. During feedback to the larger group, interaction is in English and the lecturer gives language assistance when required.

** These modules are presented in hybrid mode.

Excerpts from the Language Policy of Stellenbosch University, December 2021 (all subsections apply to the language specification option indicated in the table above):

Separate lectures in Afrikaans and English (A/E or Parallel medium)

7.1.3 For undergraduate modules where it is reasonably practicable and pedagogically sound to have more than one class group:

7.1.3.1 There are separate lectures in Afrikaans and English.

7.1.3.2 Learning opportunities, such as group work, assignments, tutorials and practicals involving students from various language groups are utilised to promote integration within programmes.

7.1.3.3 Students are supported in Afrikaans and English during a combination of appropriate, facilitated learning opportunities (e.g. consultations during office hours or scheduled tutorials and practicals).

Both Afrikaans and English used in the same lectures (A+E or Double medium)

7.1.4 For undergraduate modules where both Afrikaans and English are used in the same class group, the combination of facilitated learning opportunities is as follows:

7.1.4.1 During each lecture, all information is conveyed at least in English and summaries or emphasis on content are also given in Afrikaans. Questions in Afrikaans and English are, where reasonably practicable, answered in the language of the question.

7.1.4.2 Students are supported in Afrikaans and English during a combination of appropriate, facilitated learning opportunities (e.g. consultations during office hours, or routinely scheduled tutorials and practicals).

7.1.4.3 For first-year modules, SU makes simultaneous interpreting available on-site or online during each lecture. During the second and subsequent years of study, simultaneous interpreting is made available by SU upon request by a faculty, if the needs of the students warrant the service and SU has the resources to provide it. If two weeks have passed with no students making use of the interpreting service in a module, it may be discontinued.

One language only (A/E/X or Single medium)

7.1.5 In the following instances, lectures will be offered in one language only:

7.1.5.1 Where the nature of the subject matter of the module justifies doing so, for example, where the module is on the language itself.

7.1.5.2 Where the assigned lecturer is proficient to teach only in Afrikaans or English. For these modules additional support is provided:

(a) If the lectures are in Afrikaans, SU makes simultaneous interpreting in English available on-site or online during each lecture. If the lectures are in English, SU makes simultaneous interpreting of the first-year modules available in Afrikaans on-site or online during each lecture. During the second and subsequent years of study, SU makes simultaneous interpreting available in Afrikaans on-site or online upon request by a faculty, if the needs of the students warrant the service and SU has the resources to provide it. If two weeks have passed with no students making use of the service in a module, it may be discontinued.

(b) In addition to lectures and where reasonably practicable, there are appropriate, facilitated learning opportunities (e.g. consultations during office hours, or routinely scheduled tutorials and practicals) in Afrikaans and English.

7.1.5.3 Where all the students in the class group have been invited to vote by means of a secret ballot and those students who have voted, unanimously agree to it, the module will be presented in Afrikaans only or English only, provided that the relevant lecturers and teaching assistants have the necessary academic language proficiency and agree to do so.

Taalimplementeringsplan vir 2025² [TIP]

19 Maart 2025

1) Inleiding

Die Fakulteit Ekonomiese en Bestuurswetenskappe (EBW) se taalplan is daarop gemik om die hersiene taalbeleid, wat op 2 Desember 2021 deur die Raad en Senaat goedgekeur is, te implementeer. Hierdie implementering geskied in die konteks van 'n groot fakulteit met 'n wye verskeidenheid voor- en nagraadse programme en studente. Dit bou voort op die beduidende evolusie van die Fakulteit se taalaanbod die afgelope paar jaar ten einde toegang te verbreed en steeds 'n veeltalige aanbod te handhaaf. EBW beskou veeltaligheid as 'n belangrike professionele bate vir studente en 'n hulpbron in Suid-Afrika.

Met die oog op die TIP 2025, is 'n vraelys aan alle voorgraadse modulekoördineerders gestuur om hul insette te verkry (met inagneming van studenteterugvoer wat hulle in 2024 ontvang het, geprojekteerde studentgetalle, pedagogiese benaderings, beskikbaarheid van personeel en geprojekteerde werkstewysing vir 2025). Insette van studente is by wyse van moduleterugvoer en terugvoer via formele kanale bekom. Alle terugvoer is in hierdie verslag saamgevat.

2) Doelwitte van die TIP en veeltaligheid

Die hoofdoel van die TIP is om 'n bydrae tot US se Visie 2040 en Strategiese Raamwerk 2019 – 2024 te maak. In die lig van die Fakulteit se leergerigte benadering tot onderrig en leer, moet die taalplan aan die behoeftes en taalvoordele van fakulteitstudente voldoen. Deur daaraan te voldoen, fasiliteer die TIP die verwesenliking van die kern- strategiese temas van veral (1) 'n transformerende studente-ervaring en (2) netwerkvormende en samewerkende onderrig en leer.

Hoewel die TIP die onderrigtaal van formele lesings en leerstof bepaal, is dit slegs een komponent van die leergerigte benadering tot leer en onderrig. Die Fakulteit gebruik tradisioneel verskeie aanvullende en gefasiliteerde kontakleergemeenthede bo en behalwe

formele lesings, bv. 'n wye reeks tutoriale en informele portuur-mentorskapgeleenthede. Dit bied 'n geleentheid om veeltaligheid te bevorder.

Die meeste tutoriale en praktiese sessies word in dubbelmedium (waar Afrikaans sowel as Engels in dieselfde lesing gebruik word) aangebied. In dié geval is dosente en/of tutors beskikbaar om studente in hul voorkeurtaal te help.

Sover moontlik word een-tot-een gesprekke in die student se voorkeurtaal gevoer. Dosente wend 'n daadwerklike poging aan om isiXhosa te leer om met studente in hul huistaal te kan kommunikeer; selfs al is dit op 'n basiese vlak. Generatiewe Kl-hulpmiddels word ook ingespan om met studente in hul voorkeurtaal te kommunikeer.

Verskeie modules gebruik Mobilex of ander woordelyste om studente met hul leerwerk te help (bv. Statistiek 214, Inleiding tot Ekonomiese Finansiële Rekeningkunde 178). Eweknie-leer word ook gebruik om veeltaligheid te bevorder tydens interaktiewe lesings, groepwerk vir assessorings en tutoriale/praktiese sessies.

Bo en behalwe die meer informele, gefasiliteerde leergeleenthede, het sommige modules doelbewus dubbelmedium as taalspesifikasie gekies om pedagogiese doelwitte te bereik (bv. 'n verskeidenheid standpunte) wat veeltaligheid kan help ontwikkel.

3) Taalgebruik in onderrig en leer

Die taalspesifikasie vir elkeen van die Fakulteit se modules in 2025 word in Aanhangsel A vervat en sluit die volgende oopsies per jaargroep vir volkontak-modules in:

Die Fakulteit sal voortgaan om voorgraadse B-grade en voorgraadse diplomaprogramme in die volgende taalopsies aan te bied: aparte lesings in Afrikaans en in Engels (A/E of parallelmedium; 7.1.3 in die US-taalbeleid); beide Afrikaans en Engels word in dieselfde lesing gebruik (A&E of dubbelmedium; 7.1.4 in die US-taalbeleid); of, in uitsonderlike gevalle, word sommige modules slegs in een taal aangebied (A|E|X of enkelmedium; 7.1.5 in die US-taalbeleid). In die laasgenoemde geval word intydse tolking voorsien na gelang van behoefté en haalbaarheid.

Alle voorgraadse diplomaprogrammodules by die Skool vir Publieke Leierskap (SPL) sal steeds in enkelmedium (Engels) aangebied word. Dit is deur die studenteprofiel, afleweringsmetode (insluitend die hibriede metode) en studentegetalle genoodsaak. Die (voorgraadse) Diploma in Volhoubare Ontwikkeling en die Gevorderde Diploma in Volhoubare Ontwikkeling maak albei grotendeels staat op ervaringsleer; derhalwe leen die pedagogiese benadering hom nie tot intydse tolking nie, bv. sessies word in die buitelug by toepaslike terreine aangebied en sessies sluit praktiese leer, groepwerk, veldwerktoere, ens. in. In beide hierdie programme verwys onderrig wat van aangesig tot aangesig plaasvind, nie na tradisionele lesings nie.

Die programme beskik oor relatief klein studentegetalle en studente se kultuur, taal en agtergrond verskil grootliks. Die fasilitateerders van die programme is meestal ad hoc personeel van buite die Universiteit wat nie Afrikaans of isiXhosa magtig is nie en derhalwe nie in hierdie tale onderrig kan gee nie.

Alhoewel daar aangedui word dat hierdie modules in enkelmedium (Engels) aangebied word, is daar steeds plek vir veeltaligheid in die programme, bv. studente gebruik hul voorkeurtaal om idees in kleingroepe te bespreek. Fasilitateerders wat ander tale magtig is, kommunikeer met kleingroepe in daardie tale. Weens die aard van die sessies en die metodes wat gebruik word, help studente mekaar wanneer hulle dit moeilik vind om hulself in Engels uit te druk. Die program maak voorsiening vir ondersteuning om studente se kommunikasievārdighede te ontwikkel ongeag hul eerste taal, bv. by wyse van inisiatiewe soos geskeduleerde sessies by die Skryflaboratorium, die ReadTheory-program (om studente te help om met begrip te lees) en Strategiese Kommunikasie-modules.

Die Diploma in Openbare Aanspreeklikheid en die Gevorderde Diploma in Openbare Aanspreeklikheid het albei 'n baie spesifieke teikenmark (munisipale werkers). In dié geval word Engels as 'n universele, professionele taal beskou en is dus die gekose onderrigtaal.

3.1. Veranderings aan die taalspesifikasie van voorgraadse modules in 2025

Die Fakulteit het opeenvolgende jare met 'n hoë eerstejaarsinskrywingskoers beleef. Dit het tot meer klasgroepe en lokaalkapasiteitsbesperkings aanleiding gegee. Terselfdertyd het personeel gerapporteer dat studente Afrikaanse groepe baie swak bywoon. Om die Fakulteit se lokale die beste te benut, met inagneming van die beskikbare personeel en hul taalvaardighede, is veranderings aan die taalspesifikasies van modules aangebring wat deur die Fakulteit aangebied word. Dit geld veral die Departemente van Ondernemingsbestuur en Bedryfsielkunde en die Skool vir Rekeningkunde. Nuwe modules sal ook in 2025 geïmplementeer word.

Die volgende veranderings word in 2025 gemaak:

- In die **Departement Ondernemingsbestuur**:
 - Was daar 'n beduidende afname in die belangstelling vir Afrikaanse lesings en tutoriale. In die meeste gevalle het geen studente opgedaag vir Afrikaanse tutoriale nie en tussen een en 20 studente het lesings in Afrikaans bygewoon. Dit lei tot verwisting van hulpbronne wat beter aangewend kan word in ander groot groepe waar beperkings bestaan. In die verlede is alle modules van die Departement Ondernemingsbestuur in parallelmedium aangebied. In ooreenstemming met die US-taalbeleid sal alle eerstejaarsmodules steeds in parallelmedium aangebied word. Tweedejaars- en derdejaarsmodules sal vanaf 2025 in dubbelmedium of enkelmedium aangebied word.
 - In 2025 is 'n afwyking van die taalbeleid goedgekeur. Entrepreneurskap en Innovasiebestuur 214, Bemarkingsbestuur 214, Bemarkingsbestuur 244 en Finansiële Bestuur 332 is as dubbelmedium in die TIP van 2024 aangedui. Weens personeel indeling en personeel se taalvaardigheid is goedkeuring verleen om hierdie modules in enkelmedium (Engels) met intydse tolking in 2025 aan te bied. (Dit is by dei Fakultetsraad op 28 Februarie 2025 ter tafel gelê).

- In 2024 is 'n afwyking van die taalbeleid in die **Departement Bedryfsielkunde** goedgekeur. Bedryfsielkunde 224, 252 en 262 is as parallelmedium in die TIP van 2024 aangedui. Weens beperkte personeelkapasiteit, die personeel se taalvaardigheid en klein Afrikaanse groepe (12 – 50 Afrikaanse studente vs 230 – 270 Engelse studente) en swak bywoning van die Afrikaanse groepe (2 – 5 studente per lesing), is goedkeuring verleen om hierdie modules in enkelmedium (Engels) met intydse tolking in 2024 aan te bied. (Dit is by die Fakultetsraad op 1 Maart 2024 ter tafel gelê.) Die Departement beskik verder oor min personeel en maak staat op gekontrakteerde dosente. Aangesien die omstandighede onveranderd sal voortduur in 2025, sal hierdie afwyking in die TIP van 2025 geïnkorporeer word. Dit is nie finansieel volhoubaar om aan te hou om hierdie modules in parallelmedium vir die klein getal studente aan te bied nie.
- In die **Departement Statistiek en Aktuariële Wetenskap** is die veranderings:
 - Finansiële Risikobestuur 314 is in dubbelmedium in 2024 aangebied en sal in enkelmedium in 2025 aangebied word. Die Departement is bevoorreg om 'n bekroonde kundige in die veld as dosent van die module te hê. Die dosent is nie bedreve in Afrikaans nie.
 - In die 2024 TIP is Statistiek en Datawetenskap 188 aangedui as parallelmedium en praktiese sessies in dubbelmedium. Weens die aard van die module (spesifiek die Datawetenskapgedeelte) en personeelbeperkings, is die hele module egter in dubbelmedium aangebied ('n afwyking wat op 1 Maart 2024 by die Fakultetsraadvergadering ter tafel gelê is). In 2025 sal hierdie veranderde taalspesifikasie voortgesit word as gevolg van die beperkte aantal rekenaargebruikersareas en die groot getal studente wat vir die module inskryf. Die rooster laat eenvoudig nie aparte Afrikaanse en Engelse praktika toe nie en personeelbeskikbaarheid is nie voldoende vir aparte Afrikaanse en Engelse lokale nie.
- In die **Skool vir Rekeningkunde** is die veranderings:
 - Weens onvoorsiene beperkte personeelkapasiteit (een van die personeellede wat aan die betrokke modules toegewys is, was op verlengde siekteleverlof), taalvaardigheid van die beschikbare personeel en die aard van die moduleinhoud (sageware, KI, digitale vaardighede en vaktaal wat net in Engels beschikbaar is), wyk die 2024-taalspesifikasies van die Digitale en Leierskapsvernuf vir Rekenmeesters-module af van die goedgekeurde TIP van 2024 (wat op 1 Maart 2024 by die Fakultetsraad ter tafel gelê is) en die verandering sal ook in 2025 so geïmplementeer word:
Die teoriegebaseerde eerstejaarsmodule in die eerste semester, Digitale en Leierskapsvernuf 112, wat as parallelmedium in die 2024-TIP aangedui is, sal in dubbelmedium in 2025 aangebied word (soos in 2024, met die goedgekeurde afwyking). Die module sal intydse tolking aan studente beschikbaar stel gedurende lesings.
In 2025 sal Digitale en Leierskapsvernuf 122, 142, 152, 162, 212, 245, 312 en 253 in enkelmedium (Engels) aangebied word. Hierdie modules het 'n gemengde formaat wat meer gepas is vir die module-inhoud wat onderrig word. Gedurende praktiese klasse wat van aangesig tot aangesig deur dosente en klasassistente gefasiliteer word, word studente in hierdie modules individueel ondersteun in Afrikaans of Engels (waar moontlik). Alle hoofassesseringsgeleenthede is in Afrikaans en Engels beschikbaar.
 - Hoewel Ouditkunde 288 en 388; Sake-etiek 214; Finansiële Rekeningkunde

278, 288 en 389; Bestuursrekeningkunde 278 en 288; en Belasting 298 in parallelmedium aangebied is, sal dit vanaf 2025 verander na enkelmedium (Engels) met intydse tolking na Afrikaans. Die getal studente wat vir hierdie modules inskryf, noodsak die aanbieding van modules in groepe. Terwyl die Afrikaanse groepe baie klein is (minder as 10 studente woon elke groep by), is die Engelse groepe só groot dat dit aktiewe deelname deur studente verhoed. Verder plaas dit druk op dosente wat Engelse groepe onderrig wanneer een-tot-een konsultasies benodig word. Die Afrikaanse groepe sal derhalwe na Engelse groepe, met intydse tolking na Afrikaans, verander word.

Die Fakulteit sal die volgende nuwe modules vanaf 2025 aanbied:

- Digitale en Leierskapsvernuf vir Rekenmeesters 246 sal in enkelmedium aangebied word. Dié module vervang Digitale en Leierskapsvernuf 242. Bewysportefeuilje: Rekeningkunde 345 sal in enkelmedium (Engels) aangebied word. Hierdie veranderings maak deel uit van die Skool vir Rekeningkunde se akademiese vernuwing in ooreenstemming met die Suid-Afrikaanse Instituut vir Geoktrooieerde Rekenmeesters (SAICA) se CA2025-projek met die naam *Chartered Accountant of the Future*.
- Entrepreneurskap-inkubator en Sosiale Entrepreneurskap vervang Entrepreneurskap-inkubator 151 in die Gevorderde Diploma in Volhoubare Ontwikkeling. Dit is gedoen ter vernuwing van die gevorderde diploma nadat dit die eerste keer aangebied is. Dit bied studente meer buigsaamheid en kan die deurvloeikoers verhoog van hierdie studente wat leer én verdien. Die nuwe modules sal albei in enkelmedium aangebied word as deel van die hibriede program.

4) Administrasie- en bestuurstaal

Besluite rakende die administrasie- en bestuurstaal sal die bevordering van begrip en inklusiwiteit ten doel hê. In die algemeen sluit kommunikasie vir administratiewe doeleinades beide Afrikaans en Engels in, wat impliseer dat alle amptelike, geskrewe dokumente in Afrikaans en Engels sal wees. Kommunikasie met huidige en voornemende studente sal ooreenkomsdig die taalvoorkeur van 'n student in Afrikaans of Engels wees. Op nagraadse vlak sal kommunikasie egter hoofsaaklik in Engels wees, maar dit sal ook die onderrigtaal van die onderskeie departemente weerspieël.

Die taal van e-poskommunikasie tussen personeel word nie voorgeskryf nie, maar daadwerklike pogings word aangewend om in die taal te kommunikeer wat deur alle ontvangers verstaan word. Dit verminder die vertalingstyd en -koste van e-pos. In vergaderings sal die konteks van 'n vergadering en die deelnemers die voertaal bepaal.

5) Kanale vir terugvoer oor implementering

Studente en personeel kan terugvoer oor die implementering van die taalplan verskaf deur middel van die Fakulteit se bestaande studentestrukture, naamlik die Ekonomiese en Bestuurswetenskappe Studentekomitee (EBSK) en klasverteenvwoordigers, asook die fakulteitskomitee. Studente gebruik ook die bestaande module-terugvoermetodes. In die praktyk rig studente egter dikwels hul taalterugvoer regstreeks aan 'n dosent of die voorsitter van 'n departement en gebruik hulle slegs formele kanale indien kwessies nie opgelos word nie.

6) Ten slotte

Die Taalimplementeringsplan vir 2025 ondersteun die US se Visie 2040 en die Strategiese Raamwerk 2019 – 2024. Onvoorsiene afwykings van hierdie plan sal in ooreenstemming met die Universiteit se Taalbeleid ingedien word.

(b) Benewens lesings is daar toepaslike, gefasiliteerde leergeleenthede waar prakties moontlik (byvoorbeeld konsultasies in kantoortyd of normale, geskeduleerde tutoriale en praktika) in Afrikaans en Engels.

7.1.5.3 Waar alle studente in die klasgroep genooi is om deur middel van 'n geheime stemming te stem en daardie studente wat stem, eenparig daartoe instem, sal die module in slegs Afrikaans of slegs Engels aangebied word, mits die betrokke dosente en onderrigassistente oor die nodige taalvaardigheid beskik en instem om dit te doen.
