Our Postgraduate Diploma in Financial Planning is the first step towards the coveted CFP accreditation. A few pointers concerning our programme for 2016:

Lectures:

During 2016 we will present the four modules of the course at our **Bellville Park Campus**, **biweekly** lectures from 18:00 to 21:00, on Tuesday and Thursday evenings.

Our lecturers are specialists in their respective fields, and our results outstanding.

This is a residential based course and not a distance learning programme. Alternative institutions, e.g. the University of the Free State, present the course via distance learning.

The four Modules:

10455-711 Mod 1: Financial Planning Environment - 30 credits

10647-742 Mod 2: Personal Financial Planning - 30 credits

10574-713 Mod 3: Corporate Financial Planning - 30 credits

10454-744 Mod 4: Case Study - 30 credits

One or two years:

The four modules are presented consecutively, therefore it is possible for students with extensive experience in the financial planning, to complete the four modules within one year. However, we recommend the two year option.
