## **ASSESSMENTS**

## Assessment methods information

Participants will be individually assessed by means of the following methods (with weightings of each assessment indicated in brackets):

- A daily written open-book continuous assessment exercise based on the work of the day and based on the application taught during the contact time whereby the participant must give evidence of the ability to apply concepts and theories (40%); and
- 2. Written narrative assignment discussing context-specific questions relating to specific outcomes (60%).

### Assessment criteria information

Through the assessment, each participant must individually prove that he/she can fulfil the set outcomes and apply the knowledge of, insight and skills in South African public sector law specifically in the application of the Municipal Regulations on Financial Misconduct and Criminal Proceedings in general and his/her own work in particular. For successful completion, the average of all assessments must be a minimum of 50%.
