

# MEd (PSYCH) 2022 EDUCATIONAL PSYCHOLOGY

1. Aims of programme: See Calendar 2021 Part 6, pages 72-74

The aim of this programme in Educational Psychology is the development of research capacity, theoretically grounded knowledge, skills and attitudes, which will equip students to practise as educational psychologists in the South African context. Students who successfully complete this programme as well as the subsequent 12-month prescribed internship and who have successfully passed the Board Exam will be eligible to register as educational psychologists with the Health Professions Council of South Africa (HPCSA).

- 2. Admission requirements: See Calendar 2021 Part 6, page 72-74
- **BEdHons in Educational Psychology** (thus BPsych equivalent) <u>OR</u> **BEdPsych** <u>OR</u> an approved honours degree in Psychology.
- Psychology up to the third-year level is compulsory.
- An approved teacher's qualification, which has been acquired from a recognised national education and training institution and accredited according to the requirements of a South African teaching qualification at NQF Level 7 (e.g. PGCE or BEd). In the case of international qualifications, the qualification has to be verified as equivalent to a South African teaching qualification by the South African Qualifications Authority (SAQA) (see <a href="www.saqa.org.za">www.saqa.org.za</a>) and the official documentation has to be included with the application for the programme.
- A minimum of two years' teaching experience, which has been obtained after completion of the teaching qualification and at a formal educational institution. Experience has to be full-time employment and not part-time. Teaching practice and internship do not qualify as teaching experience.
- A minimum of **65%** for Educational Psychology or Psychology subjects at honours level.
- Should 'equivalent' alternative qualifications be submitted instead of required academic qualifications, it is the responsibility of the applicant to provide proof of equivalence.

#### 4. Selection:

The selection process takes place in two phases:

<u>Phase 1</u>: During this phase, all applications will be screened for compliance with basic admission requirements. Submission of an application form does not ensure that you will automatically be invited to the selection interviews.

<u>Phase 2</u>: The selection process for 2022–2023 takes place at the Faculty of Education, Ryneveld Street, Stellenbosch. Candidates who qualify for the selection process and who must attend the **Phase 2** will be invited via e-mail after July.

- Dates for Phase 2: Monday 27 September Thursday 30 September 2021
- Documentation, e.g. CVs, referral reports and further information will be requested at this stage.
- 5. Duration and programme presentation: Two-year part-time:

<u>First year:</u> Academic modules and approval of research proposal.

<u>Second year:</u> Practicum module, approval of internship programme (submission end of July) and completion of thesis.

<u>Third year</u>: A **12-month** approved **internship** arranged by the student

<u>Registration:</u> Students who successfully complete this programme as well as the subsequent 12-month prescribed internship and who have successfully passed the Board Exam will be eligible to register as educational psychologists with HPCSA.
