#### **EXECUTIVE SUMMARY - 2020**

The year was challenged by the COVID-19 pandemic, especially during the initial lockdown. The challenges included the difficulties experienced by essential health care staff with children with no access to child care facilities; COVID-19 infected essential health care staff and fear. Furthermore, the impact on essential health care service delivery to children were difficult as COVID- patients were prioritised, leading to delays in the management of ordinary conditions for example surgical management of hernias, which led to increased morbidity in these children. There was a decrease in both in-patient admissions and ambulatory patient visits due to several lockdowns. This trend was observed world wide and due to a significant reduction in acute respiratory infections, cessation of routine primary care clinics, and decrease in seeking health care due to fears associated with visiting health care centres. This led to late presentations of diseases, especially seen in paediatric oncology. Of concern was the increase in the mortality rate from 2.3/1000 admissions to 4.3/1000 admissions. Both neonatal services and paediatric oncology services remained under pressure with often bed occupancy rates exceeding 100%. Fortunately the paediatric health care team was able to function optimally with good support to each other during the time and with a successful pass rate of all students regardless of the challenges posed by online exams and teacing.

This is due to space within G3 and other paediatric wards as well as COVID pandemic. Patients from referral hospitals was then seen at outpatients after discharge. We had 24 patients in neonatal wards, 26 in general wards, 8 patients in G4 and 18 patients in G10 and managed 30 patients in outside hospital with telephonic interaction with clinicians in various hospitals.
