#### Mr Will Stevens

# Deputy Consul General and Public Affairs Officer, U.S. Consulate Cape Town

Will Stevens begins work as the Deputy Consul General and Public Affairs Officer at the U.S. Consulate General in Cape Town South Africa in July 2019. Prior to arriving in South Africa, Mr. Stevens was the Director of the Foreign Service Institute's Public Diplomacy (PD) Training Division, where he oversaw the training of the State Department's entire public affairs and public diplomacy corps. In 2014, he received the Edward R. Murrow Award for Excellence in Public Diplomacy, the State Department's highest award for public diplomacy work, for his work leading the U.S. Government's Interagency Task Force on countering Russian propaganda during the Ukraine crisis.

Mr. Stevens is an experienced Foreign Service Officer with overseas experience in Russia, Turkmenistan, Israel, and Belarus, as well as experience in Washington in the Bureau of Education and Cultural Affairs and the Bureau of African Affairs. In the Bureau of African Affairs, Mr. Stevens was a Senior Advisor on countering violent extremism and also served as Spokesperson for Bureau, where he directed the public affairs planning and messaging for the 2014 U.S.-Africa Heads of State Summit, which brought together 50 African leaders in Washington for the first time. Mr. Stevens was the Spokesperson for the U.S. Embassy in Moscow from 2014-2016, where his team's work was recognized in the Public Diplomacy Council's annual "Ten Best" for the "Best Use of Social Media by an Embassy." He has also served as Chief of Staff at the Bureau of Educational and Cultural Affairs, chief of public affairs at the U.S. Embassy in Turkmenistan, and in the press and cultural affairs offices at the U.S. Embassy in Tel Aviv.









A native of Great Falls, Virginia and a graduate of Brigham Young University, Mr. Stevens is married with five children. He is an avid football and basketball player and addicted Twitter user - @Wbstevens.

#### Mr Adam Bacheller

Mr. Bacheller is the Strategic Trade and Export Control Trainer for the United Nations Office on Drugs and Crime (UNODC) Container Control Programme (CCP). In this role, he interacts with officials throughout the world delivering CCP training. Prior to joining the CCP team six years ago, he provided his knowledge and expertise for seven years to the International Atomic Energy Agency's Office of Nuclear Security. 
# **Dr Robert Besseling**

# Prof A.J. Esterhuyse

Abel Esterhuyse is head of the Department of Strategic Studies in the Faculty of Military Science, Stellenbosch University, at the South African Military Academy and research associate of the Centre for Conflict, Rule of Law and Society (CRoLS) at the Bournemouth University in the UK. He holds a PhD from the University of Stellenbosch and is also a graduate of West Point Summer Programme in Military History and the Programme on the Analysis of Military Operations and Strategy (SWAMOS) of Columbia University's Saltzman Institute of War and Peace Studies in New York. Prof Esterhuyse is a rated scientist of the South African National Research Foundation. His most recent publication, titled *The practice of strategy: South African defence in stasis*, was published in the British journal *Defence & Security Analysis*. Between 2010 and 2015, Prof Esterhuyse served as the editor of *Scientia Militaria: The South African Journal of Military Studies*.

# William J. Flanagan

Mr. William Flanagan is an experienced customs and border security official and former Deputy Attaché with United States Department of Homeland Security who has more than thirty years of experience working with the U.S. Government and in the area of Homeland Security and International Law Enforcement. From 2011 to the present, Mr. Flanagan has supported Defense Threat Reduction Agency (DTRA) International Counter Proliferation Program (ICP) facilitating the development of a border security strategies and national counterproliferation strategies for countries in Europe and the Middle East.

From 2002 to 2008, Mr. Flanagan served as U.S. Homeland Security Deputy Attaché and later Acting Attaché at the U.S. Embassy in Vienna, Austria. In these capacities,







he interfaced and supported programs throughout Eastern Europe, with customs and border security agencies in thirteen countries in Southeastern Europe and the Balkans. Mr. Flanagan was involved in numerous international cross border investigations involving illegal exports, critical technology, money laundering, human smuggling and fraud. He worked with a variety of countries assisting these in the modernization of border security procedures and Customs inspection procedures. In addition, in this post, he routinely worked with law enforcement agencies including the European Union, Europol and Interpol.

# **Mr Dave Hargreaves**

Mr. Hargreaves is a Specialized Officer within INTERPOL's Counter Terrorism Directorate. He currently manages several chemical security programs in partnership with INTERPOL member countries, including Iraq, Pakistan and Jordan as well as across regions in Africa and South East Asia. These programs develop coordinated and sustainable control measures to prevent unlawful access and diversion of high hazard and precursor chemicals as they enter or exit a country, as well as during transport, storage and at point of sale. He also coordinates regional multi-agency operations that interdict illicit cross border movement of terrorists and WMDs. Mr. Hargreaves also works as a special advisor on counter proliferation with the UK Foreign and Commonwealth Office Arms Control and Verification Research Unit. Prior to joining INTERPOL Mr. Hargreaves served as a police officer in London for 30 years, the last four as Head of Training at the UK National CBRN Centre, where he led all CBRN training for UK Police, Fire and Ambulance services. He was a key participant in the creation of the UK border control capability to detect and interdict illicit WMD materials crossing land, sea and air borders. This included the selection and testing of detection equipment, as well as drafting command protocols, decision making models and response tactics. He was also police specialist adviser to Project

Lieutenant General Barney Muntu Norman Hlatshwayo was born on 19 November 1958 in Soweto. He became Chief Joint Operations from 1 January 2017 and promoted to Lieutenant General. Career highlights include playing a leading role in negotiating APLA's integration into the SANDF and being appointed as Chief Military Advisor for the facilitation of the Burundi peace process where he assisted in concluding peace agreements with the armed political parties in Burundi.

# Maj Gen (ret) Johan Jooste

Head of Special Projects South African National Parks


Maj Gen (ret) Johan Jooste (66) retired from the South African Army in 2006 after 35 years of active service. He is a war veteran and the last part of his military career he served in the Army General Staff in various capacities, but always involved with strategy, leadership development and knowledge management. Apart from his experience his learning path through four universities (including an MBA) served him well in this period. He joined a small company in the military vehicle business in 2006 and two years later took up a position with a multinational company, BAE Systems Land Systems, where he was the Director Business Development. At the beginning of this 2013 he was appointed as Commanding Officer Special Projects at SAN Parks, responsible for all matters related to the anti - poaching strategy, planning and execution. The current focus is the Rhino poaching in the Kruger National Park, but he is also managing a Wildlife Crime and Corruption Combatting Coordination Centre at the SANParks Head office. Dr Assis Malaquias is Professor and Chair of the Department of Global Studies and Maritime Affairs at the California State University (Maritime Academy). He is also Associate at he Corbett Center for Maritime Policy Studies, King's College, University of London. He has an extensive and distinguished career in academia and public service. Prior to joining Cal Maritime, he served as Overseas Maritime Security Advisor in the Africa Bureau, US Department of State. He also served as the Academic Chair for Defense Economics at the National Defense University's Africa Center for Strategic Studies. Professor Malaquias' previous appointments include: Associate Dean of International and Intercultural Studies and Professor of Government at St. Lawrence University in Canton, New York; Extraordinary Associate Professor of Political Studies at the University of Western Cape in South Africa; and a visiting Professor at Stellenbosch University, also in South Africa. He holds a B.A. (Honors) in Political Science from the University of Winnipeg, a Master's degree in Economics and a Ph.D. in Political Science both from Dalhousie University, Canada. His areas of specialization include International Relations, International Security, and Maritime Security.

### **Professor Thomas Mandrup**

Thomas Mandrup is an Associate Professor at Royal Danish Defence College, Denmark, an extraordinary Associate Professor at the Faculty for Military Science, Stellenbosch University and an external lecturer at the Centre for African Studies, University of Copenhagen, Denmark. He has published articles and book chapters, and co-edited several books on issues related to African security governance and South African foreign policy. His three latest co-edited books were entitled *Towards good order at Sea – African Experiences, The Brics and Coexistence – an alternative vision of world order, On Military Culture: Theory, Practice and African Armed Forces*, whilst his latest book chapter, *Denmark: How not if to Outsource Military Services* was published in *Commercialising Security in Europe* Anna Leander (Eds) Routledge/PRIO March 2013.

He received his PhD in International Relations (2007) from the University Copenhagen, Denmark Currently his is an Editorial Advisory Board member of the Scientia Militaria, South African Journal of Military Studies. Prof. Mandrup's primary research field is African Security Governance and he has extensive fieldwork experience from for instance DR. Congo, Kenya, Ethiopia, South Africa, Zimbabwe and Sudan. Prof. Mandrup recently co-authored a report on the **Effectiveness of the UN Mission (EPON) in the DRC**, based on a recent field-visit to Eastern DRC. The report is part of a larger study done under the leadership of the **Norwegian Foreign** 







**Policy Institute** (**NUPI**), and which will be running for the next four years. The **EPON project is done in cooperation with the UN and the AU**.

#### Dr Michelle Nel

Michelle Nel, BLC, LLB (Pret) and LLM, LLD (Unisa), is Vice Dean of Social Impact and Personnel and a senior lecturer in Criminal and Military law and the Law of Armed Conflict at the Faculty of Military Science, Stellenbosch University. She joined the Defence Legal Services Division in 1996 as a prosecutor and was appointed as a lecturer in the Department of Mercantile and Public Law (Mil) of the Faculty of Military Science in 2002. She was admitted as advocate to the High Court in the Cape of Good Hope in 2005 and completed her Doctor of Laws in 2012. She also serves as part-time researcher in SIGLA's maritime governance hub. Her areas of research include good governance, International Law, Military Law and Maritime Security. Her work has been published in South Africa and internationally.

Major Pereira is a former intelligence officer with two Afghanistan tours, he has 20 years of active duty service between the Army and the Navy. He has a Masters in Security Studies with a focus on Sub-Saharan Africa and a Masters in International Relations with Conflict Resolution. He is a Desert Storm and Desert Shield veteran.

# **Mr Pat Tracy**

Pat Tracy has extensive border management and internal security expertise largely gained through a full career in the British Army. Stephen van Neel gained his initial professional development expertise in the South African National Defence Force. He was exposed to Senior Management level as a Senior Staff Officer in the South African National Defence Force and served at the SA Army Combat Training Centre and SA Army College as well as the South African National War College. He also commanded peacekeeping forces as a Sector Commander in Darfur – Sudan as part of the African Union Mission in the Sudan (AMIS) and the hybrid United Nations – African Union Mission (UNAMID). Professor Paul Musili Wambua is currently an Associate Professor of Law at The University of Nairobi, Kenya where he teaches Maritime Law, the Law of the Sea, and Insurance Law. He has a special research interest in maritime security and corporate governance.
