Most importantly and without exception, projects require joint or active participation and equal ownership between scientists and IKS-knowledge holder must be clearly designated as principal investigators or co-investigators in the application. In addition, verifiable supporting evidence, in the form of the written and signed contract or agreement, of such collaboration must be submitted along with the IKS application from.

Applicants must be full time or contract staff members of the university. Contract staff must be appointed for (at least) the duration of the project applied for in the submission. A contract researcher appointed at the university on behalf of a third party to fulfill a very specific function for the latter, does not qualify to apply.

Prospective applicants are requested to

- 1. Study the programme guide carefully, specifically with regards to limits on funding categories and required motivations (Appendix 3) and the entrylevel hurdles for applications (Table 2).
- 2. Update their CV's on https://nrfsubmission.nrf.ac.za, including current postgraduate students.
- 3. 'Final submit' their applications on https://nrfsubmission.nrf.ac.za by 10:00 24 May 2017, at the latest.
- 4. Ensure that the necessary collaboration agreements with all role-players are in place and attached to the application. We advise that the IKS-holder explains in a letter his/her role in the project and what benefit he/she anticipates getting from the project.
