- Bewys van Suid-Afrikaanse mediese dekking
 - ✓ Mediese dekking moet by die SA Raad vir Mediese Skemas geregistreer word ingevolge die Wet op Mediese Skemas, 1998.
 - ✓ Gebruik asseblief die volgende skakel om te verseker dat u die korrekte mediese dekking het.

- Studente met permanente verblyfreg, vlugteling en asielsoekers moet nodige bewyse indien van hulle immigrasie dokumentasie – geen studievissum en mediese dekking word benodig nie.

PRE-REGISTRATION (VERIFICATION) of INTERNATIONAL DEGREE-SEEKING STUDENTS DOCUMENTATION BEFORE ACADEMIC REGISTRATION 2020

(Applicable to Stellenbosch campus students only)

1. UNDERGRADUATE DEGREE-SEEKING INTERNATIONAL STUDENTS: NEWCOMERS (1st year students)

The verification of documentation for newcomer (1st year) undergraduate degree-seeking international students will take place between Monday, 20 January 2020 to Friday, 24 January 2020 at the RW Wilcocks building, Crossley Room 1023.

Students must present the following compulsory documentation for pre-registration:

- Valid Passport and Study visa
- Proof of South African medical cover
 - ✓ Medical cover must be registered with the SA Council for Medical Schemes in terms of the Medical Schemes Act, 1998.
 - ✓ Please use the following link to ensure that you have the correct medical cover. www.medicalschemes.com/medicalschemes.aspx
- Students with permanent residency, refugees and asylum-seekers must submit proof of their immigration documentation that confirms their status – no study visa and medical cover is required.
- Proof of payment as per your admission letter.

PLEASE NOTE:

- ✓ **First-year international undergraduate students *do not need to apply for their matriculation exemption certificate prior to registration of the 2020 academic year***. However, you need to ensure you meet the exemption requirements by sending your final results to Ms Carmelita Talmarkes at ctalmarkes@sun.ac.za, before pre-registration.

An email confirming that you do meet the exemption requirements will be send back to you.

- ✓ All international degree-seeking undergraduate first-year students need to follow the same welcoming programme as the SA students as per the following link: www.sun.ac.za/welcome.

2. SOUTH AFRICANS WITH FOREIGN SCHOOL QUALIFICATIONS (1st year students)

- ✓ Pre-registration does **not** apply to South Africans with foreign school qualifications.
