## PREDATORY JOURNALS LIST - 2016 RESEARCH OUTPUTS

The institutional report sent to the DVC: Research, Innovation and Postgraduate studies in December 2017 on the allocation of research output units for 2016 publications refers.

The institutional report provided two lists of journals for 2016, the first identified as "predatory journals" and the second as "possible predatory journals". It indicated that the Department had taken a decision to exclude all journals published on the lists from the 2016 evaluations. It further stated, that if the journals were found to be credible in terms of the research outputs policy, the subsidy units would be awarded for these publications during the 2017 evaluation process.

Some of the journals in the list labelled "predatory journals" had been verified with ProQuest, who had confirmed that the journals had been removed from their lists because they were predatory. However, it has been brought to the attention of the department that some or all of the journals on that list may, in fact, be credible. The decision that these journals will not be subsidised has therefore been suspended. The Department withdraws the list, as indicated below, and will include all qualifying articles in these journals as part of the 2017 evaluation process, and research outputs subsidy will be generated accordingly. However the Department will continue with the verification process, and should any journal be found not to be line with the policy criteria, subsidy will be withdrawn.

The Department has all the records and information pertaining articles published in the affected journals for each institution, and we will incorporate the relevant units into the 2017 evaluation process.

The Department will continue to investigate journals and will withdraw any journal identified as predatory at any given stage. Paragraph 5.12 of the Research Outputs Policy states that:

"the Department will periodically sample journals to assess if they continue to meet the criteria. However, institutions and individuals may submit a proposal for the removal of a journal. Proposals must outline detailed reasons for the removal of such journals, in particular, stating which criteria or criterion of the policy the journal ceases to fulfil".

The Department reserves the right to withhold payment of research output subsidy in respect of any article published in a journal that does not meet the criteria as outlined in the research output policy. Researchers are urged to continue assisting the Department in this matter so as to safeguard the quality and integrity of SA's research and improve its scholarship.

Once more, the Department regrets the error and the confusion it has caused. The Department will work with institutions to develop systems to ensure that the quality of research outputs from South African universities improves, and that such administrative oversight does not recur.
