# Grant holders meeting on the 29 and 30 January 2018, Bruxelles

The YEBO! Project is funded by the Erasmus+ programme managed by the Education,

and Audiovisual Executive Agency (EACEA).

The agency is entrusted with the implementation of programmes and activities on behalf of the European Commission.

The aim of the meeting was to address some practical issues, such as grant agreement management, but also to present the midterm review of the Erasmus+ programme.

The meeting provided some excellent opportunities for networking and sharing knowledge with experienced practitioners and people from other projects in similar areas, and from other partner countries. Two representatives were present at the meeting on January 29th and 30th 2018. Camylle Pernelle as the coordinator (UM) and Leolyn Jackson as co-coordinator (CUT).



During this meeting they met with the project officer in charge of the project. The regulations concerning ERASMUS+ Capacity Building projects were presented.



To be noted: the consortium has the possibility to change some of the activities planned in the application form of the project if they are deemed not relevant during the implementation and if the Consortium agrees with it. So this allow us to be much more flexible in terms of activities if we have to in the future to best fit the needs of the partners.

Another point that has been underlined during this meeting is the importance of buying the equipment as early as possible. During the next meeting in April 2018, the partners will decide on the kind of equipment that will be purchased.

## Internationalization rate questionnaire

This questionnaire was the first step to help us clearly define the issue faced by each partners and to draw some possible solutions from it.



All of the answers to the questionnaire have been gathered. The work package leaders, VGTU and CPUT, are currently working on a report that will be presented in the next meeting on the 12th and 13th of April in Cape Town.

#### **Training Capacity**

UG and TUT are currently working together to gather all the existing training that existed among all of the partners. The information will help us evaluate the training capacity of the partners and to see what is doable for the project in term of training. A focus has been made on training that concern these three

#### **Quality Assurance**

TUB and UCT have been working on the documents that will allow us to monitor the quality of the involvement and outputs produced for every WP as well as the involvement of each partner. The Quality Charter will be presented and signed during the meeting in Cape Town.

#### Partnership Agreement

All of the fifteen partners signed the Partnership Agreement for the project YEBO! engaging them to respect the regulation put in place by the EACEA. The first funding transfer will take place by the end of April.

#### On the 12th of April:

First, the results of the internationalization rate questionnaire will be presented. CPUT, VGTU and CUT will present the conclusions and trends observed for each region (European and South African).

UM will also present how the results were gathered internally and the issues faced since everyone struggled to gather all of the information required in the questionnaire. This discussion will allow a debate as to see how the international data can be better monitored and gathered by each institution.

A session will be dedicated to the equipment and the other one on the financial and administrative management. During them will be detailed : funding amount, EACEA regulations, explanation about the transfers and the supportive documents that will need to be provided.

#### On the 13th of April:

A work session co-led by CUT on the PhD Portal is planed. This will be the occasion to define what already exists and work on the content and structure of the platform.

Most of the time for this 2nd day will be dedicated to the training sessions and conferences. The format that these activities take will be established, as well as their subjects. First list of experts to contact will be drawn.

Finally the meeting will end on a talk about the Quality Assurance. The documents who will help monitor the quality of partners' participation will be discussed and at the end of this session the quality charter will be signed.
