

Minutes of the Annual General Meeting of the Convocation of Stellenbosch University held in the Paul Roos Centre on Thursday, 26 January 2017

1. Constituting of the meeting

1.1 The President, Adv Jan Heunis SC, declared the meeting properly constituted and announced that interpreting services from Afrikaans to English were available. The meeting began at 19:45. The following house rules applied for the duration of the meeting:

- 1.1.1 The Statute of Stellenbosch University (SU).
- 1.1.2 The procedures of the meeting (Council document).
- 1.1.3 The language policy of SU (provisions regarding official meetings).

2. Opening

2.1 The Convocation maintained a moment of silence.

2.2 Thought was given especially to Convocation members who had passed away since the last annual general meeting (AGM).

3. Welcome

3.1 The President welcomed all attendees, including Convocation members, their spouses, guests and the media.

3.2 The President closed the agenda. No requests had been received 72 hours before the AGM (as determined by the Statute) regarding specific points for discussion or proposals for acceptance on the agenda.

4. Minutes of the previous AGM (Tuesday, 26 January 2016)

4.1 The minutes of the previous AGM were deemed as read.

4.2 The minutes were accepted.

5. Awards to the previous President, Prof C Viljoen, and the Rector, Prof W de Villiers

5.1 The Vice-President, Adv Jacques du Preez, and additional member Dr Sonja Loots presented Prof Viljoen and Prof De Villiers with gifts.

9. Questions by the members of the Convocation to the Executive Committee of the Convocation and the Rector

9.1 Questions included those from poet Lina Spies and the previous President, who both expressed their misgivings about SU's new language policy.

9.2 Another member of the Convocation asked why her daughter, an A-student, was excluded because she was white.

9.3 Mr Chris Otto questioned the President on his involvement in the *Gelyke Kanse* (Equal Opportunities) court case against SU's language policy.

9.4 The Rector, however, had already indicated before the meeting that he would not answer questions.

10. Motions

10.1 First motion: This motion was submitted by the manager of PEN Afrikaans, Mr Danie Marais. It requested the Convocation's support of the President's participation in the court case, which aims at the setting aside of SU's new language policy. The request was accepted by the greater majority.

10.2 The second motion was submitted late but was admitted by the President: This motion was submitted by JD Blackenberg. It requested continued discussions among the various groups, the Convocation and University management to be debated more widely and more open discussions to be held to enable everyone's views to be heard and not simply those of one group. The request was accepted by the Convocation.

11. Closing

11.1 The President thanked the meeting and the ballot committee for its assistance with the election processes.

11.2 The President declared the meeting closed. The meeting adjourned at 22:00.
