1. ABOUT THE CENTRE

The Centre for Applied Ethics (CAE) is an interdisciplinary research, teaching, and service institution of the University of Stellenbosch, based in the Philosophy Department. It reports to the Faculty Board of Arts and Social Sciences. The Centre does work on its own, but also accommodates three units, viz. the Unit for Bioethics, the Unit for Environmental Ethics and the Unit for Business Ethics and Public Integrity. The Tygerberg Division of the Unit for Bioethics ceased to exist from 2012, and was replaced by the Centre for Medical Ethics and Law, fully situated in the Department of Medicine in the Faculty of Medicine at the Tygerberg Campus. There is mutual representation on the governing boards of these two Centres, and the latter came into existence with the consent of the CAE. Their respective activities and commitment to not unduly overlap are circumscribed in a Memorandum of Understanding that will be revised every five years.

5. Other general activities of the Centre

5.1 Teaching

In 2012 we saw the first intake of students in the newly created one year Postgraduate Diploma in Applied Ethics. We were forced to replace our traditional two year MPhil (Applied Ethics) with this program, followed by a one year MPhil in Applied Ethics, that will start running in 2013. It is clear that we will have to rethink the admission conditions for the MPhil, since applications for that program, which will start running in 2013, were plentiful and revealed excellent students, but at the same time people who are not interested in first doing a PG Dip, since they already have very advanced degrees. This dispensation which prohibits two year masters degrees is an imprudent one and at the moment a distinct threat to the teaching function of the Centre.

In November 2012, prof. van Niekerk was invited by the Philosophy Faculty and the Centre for Ethics at the Radboud University, Nijmegen, to deliver a number of postgraduate seminars and participate in two conferences, one dealing with a paper that he wrote on enhancement.

Prof. Paul van Tongeren from the Radboud University in Nijmegen, Netherlands, took care of and entire Honours course and delivered a lecture on Nietzsche's ethics. Prof. Philippe van Haute of Nijmegen also visited and lectured, as did proff. David Spurrett from UKZN, Ernst Wolff from UP and Mark Colyvan from New Zealand.

Prof. van Niekerk also serves as chair of the Board of Directors of the Ethics Institute of SA (EthicsSA), whose former CEO and current Executive Director, prof. Willem Landman, serves as professor extraordinaire in the Centre and Department and renders very value services to the Centre. Prof. Deon Rossouw, current CEO of EthicsSA, has also been appointed professor extraordinnaire in the department and Centre in the course of 2012.

Prof. van Niekerk also served as member of the Task Team on Human Dignity, created by the Synods of the DRC and the Uniting Reformed Church in SA. In this capacity he wrote a chapter on illness and human dignity for a publication that is in the making and will appear in 2013.

Members of the Centre (Van Niekerk, Woermann, Hattingh and Smit) will from 2013 be involved in a new MPhil in Futures Studies, to be created at the Institute of Futures Studies at the Bellville Park.

Dr Woermann is a member of the Governing Committee for the Anticorruption Centre for Education and Research (ACCERUS); Stellenbosch University.

5.4 Quality Assessment

With the six yearly evaluation of the Philosophy Department that took place from 1 to 4 September 2012, the Centre was also evaluated. A very favourable report about both was produced by the two reviewers, prof. Emma Ruttkamp-Bloem of UP and prof. Marcel Verweij of the University of Utrecht in the Netherlands. Sue Hall's PhD (which dealt with the problem of harm and enhancement) was also completed and the degree conferred at the end of 2012, as well as Chris Verster's MPhil, which dealt with the use of stimulants and performance enhancers by health students. (Verster is a psychiatrist at Stikland Hospital).
- **1.1.2** *The history and social functions of bioethics in South Africa.* (AA van Niekerk). Prof. van Niekerk was invited to write the chapter on Bioethics in South Arica in the *Global Bioethics Ethics Atlas* which is due to be published in 2013. This has been completed.

4.2. Appointments

4.2.1. Appointment of Prof. Deon Rossouw as an extraordinary professor

As of 2013, Prof. Rossouw will serve as extraordinary professor in the Department of Philosophy and will lecture in the MPhil Applied Ethics (specialisation: business ethics) programme. Prof. Rossouw is CEO of the Ethics Institute of South Africa. He was the founding President of BEN-Africa and served as president of the International Society of Business, Economics and Ethics (ISBEE). He was a member of the research team of the Second King Report on Corporate Governance and is a member of the Sustainability Committee of the Third King Report on Corporate Governance.

4.2.2. Appointment of Dr. Woermann as the editor at large of the African Journal of Business Ethics

As of 2013, Dr. Woermann will take over from Prof. van Vuuren as editor at large of the African Journal of Business Ethics (AJoBE). AJoBE was established during 2004 as the official journal of BEN-Africa, and is accredited by the International Bibliography of the Social Sciences (IBSS).

4.2.3. Appointment of Dr. Woermann to governing committees / boards

During 2012, Dr. Woermann was appointed as part of the governing committee of the Centre for Corporate Governance in Africa; University of Stellenbosch Business School; and as a board member of Hope Association Cape Town. Hope Cape Town is a non-profit organisation providing outreach, education and counselling at the community level, focusing on HIV/AIDS and TB in the Western Cape Province of South Africa. HOPE Cape Town is co-located and associated with the Ithemba (Hope) Infectious Paediatric Ward at Tygerberg Hospital in Cape Town and is linked to the University of Stellenbosch. Dr. Woermann's portfolio is to provide ethical guidance in running the organisation.

2.4 M.Phil in Environmental Management

Prof. Hattingh is member of an interfaculty Programme Committee that has launched a Mphil Programme in Environmental Management in January 2001. Departments participating in the programme are Philosophy (Environmental Ethics), Geology, Geography and Environmental Studies, Public and Development Administration, Public Law, and Conservation Ecology. Since December 2002 a steady stream of students graduated from this program.

Within the framework of this programme Prof. Hattingh took responsibility for a module in Environmental Ethics in 2012. He also supervises students doing their research projects on themes in Environmental Ethics. From 2013 his duties in this regard will be taken over by Dr. Sue Hall.

2.5 M.Phil. in Sustainable Development

In February 2003 the Sustainability Institute under the leadership of Prof. Mark Swilling and Ms. Eve Annecke launched an innovative MPhil Programme in Sustainable Development in collaboration with the Department of Public and Development Management of the University of Stellenbosch. Having been part of the team planning the Programme, Prof. Hattingh is currently one of the co-teachers in the module on Leadership and Ethics for Sustainable Development. Prof. Hattingh will continue with his responsibilities in this context from 2013 while serving as Dean of the Faculty of Arts and Social Sciences.

2.6 Activities around UNESCO's COMEST

1. At the end of 2011 the second term of Prof Hattingh as member of COMEST (The World Commission on the Ethics of Science and Technology), an advisory body of UNESCO came to an end. COMEST falls under UNESCO's Division for the Ethics of Science, and consists of 18 members that are selected to be representative of the world community on the one hand, and expertise in the ethics of various fields on the other hand. Members are appointed to COMEST in collaboration with the official delegations of member countries of UNESCO and their countries' Ministries of Science and Technology. COMEST advises the General Assembly of UNESCO on ethical issues, and conduct, on request, research for the General Assembly on ethical issues. At the beginning of 2004, Prof. Hattingh was appointed as member of COMEST for a period of 4 years. On the recommendation of the South African

Government, Prof. Hattingh has been invited by COMEST to serve for another term of four years, i.e. from 2008 – 2011. During 2005 Prof. Hattingh was appointed as Rapporteur in the Executive Board of COMEST, a position in which he served until the end of 2011. Since May, 2008, Prof. Hattingh was invited to Chair a Working Group on Environmental Ethics to take the lead in preparing a report on The ethical implications of global climate change.

2. During 2012 Prof Hattingh was invited by the Director General of UNESCO to serve as an associate member of COMEST, which means that he can still be invited to support the activities of COMEST.

2.7 Membership of Editorial Boards

Prof. Hattingh currently serves on the Editorial Board of the following journals:

2.8 Ethics Committee for Research on Animals (ECRA)

Prof Hattingh is member of the Ethics Committee for Research on Animals of the Medical Research Council (MRC) and helps this committee to review research proposals in which experimental animals are involved. This committee has about four meetings per year. At the end of 2012 Prof Hattingh had to resign as member of ECRA with view to taking up his duties as Dean of the Faculty of Arts and Social Sciences of Stellenbosch University.

2.9 Research Ethics Committee of the CSIR

During 2009, Prof Hattingh was invited by the Board of the CSIR to serve as first Chair of its newly established Research Ethics Committee. This appointment as Chair was renewed in the first half of 2012 for another three years. However, towards the end of 2012 Prof Hattingh had to resign from this position with view to taking up his duties as Dean of the Faculty of Arts and Social Sciences of Stellenbosch University.

2.10 Awards and recognition

Towards the end of 2012 Prof Hattingh received a B rating from the NRF for his research.
