1. Do you need a VISA?

Citizens of **most European countries and the US do not require a VISA** to enter South Africa. Citizens who are holders of a national passport (diplomatic, official or ordinary) of the following countries / territories / international organisations **are not required to hold a visa**:

2. Documents required for entering South Africa:

- A valid and acceptable passport or travel document for your intended stay
- At least one blank page in your passport for endorsements
- A valid visa, **if required (see section 1 above)**
- Sufficient funds to pay for your day-to-day expenses during your stay
- A return or onward ticket
- Yellow fever certificates if your journey starts or entails passing through the yellow fever belt of Africa (see http://www.southafrica-newyork.net/homeaffairs/yellowfever.htm)

3. Applying for a VISA:

If your country of citizenship is not listed in section 1 above, please refer to the website of the Department of Home Affairs (<u>http://www.dha.gov.za/index.php/applying-for-sa-visa</u>), or contact the South African embassy in your country in order to apply for a visa.

It is recommended to start retrieving all necessary documents at least 3 months before making your trip to South Africa.

Documents required to apply for a visa

- A passport or travel document valid for no less than 30 days after the expiry of your intended visit
- Your passport must have at least TWO unused pages for entry / departure endorsements
- A completed Form BI-84 (application for a visa)
- Payment of the prescribed fee
- A yellow-fever vaccination certificate (if required)
- Statement and/or documentation confirming the purpose and duration of your visit
- Two colour passport photographs
- A return or onward ticket if you are travelling by air
- If you have children (minors) travelling with you or joining in South Africa, you will need to provide the following additional documents
 - Proof of guardianship or custody or
 - Consent from the guardian in the case of an unaccompanied minor
- Proof of financial means to pay for your living expenses while in South Africa in the form
 - of:
- o Bank statements
- o Salary advances
- Undertakings by the host(s) in South Africa
- o Bursary

- Cash available (including credit cards and travellers' cheques)
