• What is the language policy?

For BCom Honours (Management Accounting) all classes are presented in English only. All tests, projects, etc are only completed in English.

This policy is followed as the course prepares students for CIMA exams, which are only available in English.

• Is there a part time option?

Classes are only offered full-time and students are expected to attend class. A material portion of the final mark consists of marks gained during class participation and discussion. The programme runs for one year and cannot be followed over a two-year period.

• Which subjects are covered?

The syllabus is aligned with the CIMA subjects as follows:

The exemptions awarded by CIMA are at their discretion only and depend on the graduate programme that you have completed before the BComHons(Management Accounting).

Students at Stellenbosch University who completed BCom (Management Accounting), BCom (Financial Accounting) or B Accounting get exempted from paper P1 and F1. Students at other universities can visit the following link to determine whether they are exempted from certain CIMA papers:

• What are the entry requirements for BComHons (Man Acc)

For admission to **BCom Honours (Management Accounting)** in 2018, you must meet the following <u>minimum</u> requirements:

Financial Accounting third year: 60% Management Accounting third year: 60%

The above marks must be obtained within the two years preceding the intended year of study.

Selection is based on the final mark as it appears on the University's central systems. This programme is a selection programme and a <u>limited number of students may possibly be admitted</u>.

Naturally other universities may use alternative names for subjects. To determine whether your subjects would be considered, please provide Mr R Baard (<u>RBaard@sun.ac.za</u>) with the following:

- 1. Degree
- 2. Subjects
- 3. Course descriptions of third year subjects that are similar to Management Accounting and Financial Accounting.

Please note that to be eligible for selection, undergraduate degrees have to include at least three years Financial Accounting and minimum two years Management Accounting (which includes Financial Management and Cost Accounting).

• Can I gain entry to the Honours programme if I passed my exams with CIMA?

Unfortunately not. There are additional material that is covered at undergraduate level which is needed to be successful in the Honours programme.

• Can I gain entry to the Honours programme diploma, instead of a degree?

Unfortunately not. Legislation prohibits us from recognising a diploma as applicable for entry to the Honours degree programme.

• When do application close?

Applications for BComHons (ManAcc) close 31 October of the preceding year (i.e. 31 October 2017 for the 2018 academic year). Unfortunately late applications cannot be considered.

• When do classes start?

Classes start and run according to the academic calendar as followed in South Africa. Classes therefore start end January / beginning of February and comes to an end in approximately November.

• Can I transfer from another university?

You my possibly gain entry to the BComHons(Management Accounting) degree at Stellenbosch if you completed your degree at another university. However, this may influence exemptions you receive from CIMA. This is a matter which individuals need to take up with CIMA.

• What is the difference between BComHons(Management Accounting) and HonsBAcc?

The BComHons(Management Accounting) syllabus is aligned with that of CIMA and prepares students for the CIMA exams.

The HonsBAcc syllabus is aligned with the SAICA [CA(SA)] syllabus and prepares students for SAICA's First Qualifying Exam.

• What is the application procedure

There is a non-refundable application fee of R100.

• At which NQF level is the Honours programme?

BCom Honours (Management Accounting) is at NQF level 8.
