Dr Monique Emser

Monique Emser is a Senior Lecturer and Programme Coordinator of the Political Science Programme in the International and Public Affairs Cluster, School of Social Sciences, at the University of KwaZulu-Natal, South Africa. Her area of specialisation is complex crimes focusing on human trafficking. The permutations of vulnerability and violence against women and children that often render them invisible and prone to exploitation and abuse form part of her research interests. Of growing interest to her are lesser-known forms of trafficking. Monique has fifteen years' experience in counter-trafficking research and practice. Internationally, she serves as an advisory member on the G-100 Women's anti-human trafficking wing and is a member of Mission 89's international scientific research committee, while locally she is a member of the KwaZulu-Natal Human Trafficking coalition and the National Freedom Network. She is currently involved in projects examining the intersection of trafficking and sport, and developing safeguarding and anti-trafficking modules for international sporting bodies.



Prof Somadoda Fikeni

Somadoda Fikeni is a public figure who has held various leadership roles in the public sector organizations and as a scholar or public intellectual who has influenced public discourse, institution building and public policies. He is currently the chairperson of the Public Service Commission of South Africa as well as the chairperson of the Indlulamithi South Africa Scenarios Board of Trustees. Educationally, he holds BA & BA Honours (Unitra), MA (Queens University in Canada) and a PHD (Michigan State University) as well as numerous short programmes in specialized areas. Justice Richard Goldstone

Justice Richard J. Goldstone was a judge in South Africa for 23 years, the last nine as a Justice of the Constitutional Court. Since retiring from the bench, he taught as a visiting professor in a number of United States and European Law Schools. He chaired the Independent Expert Review Group established in December 2019 by the Assembly of States Parties to review the International Criminal Court and Rome Statute system. He is a deputy chair of Integrity Initiatives International and chairs its International Anti-Corruption Court Treaty Drafting Committee. From August 1994 to September 1996 he was the chief prosecutor of the United Nations International Criminal Tribunals for the former Yugoslavia and Rwanda. He is an honorary life member of the International Bar Association and Honorary President of its Human Rights Institute.



Adv Lavan Gopaul

Adv Lavan Gopaul is an Advocate of the High Court of South Africa. Kerotse Kekana holds an undergraduate degree in International Relations and pursued postgraduate studies in Public Administration and Management at the University of Pretoria. With a teaching career since 2018, she has contributed to the development of modules and curriculum in Political Science and International Relations across various higher education institutions. Her research interests lie in the areas of Poverty Alleviation, Sustainable Development, South African Governance, and Stakeholder Relations.



Minister Noxolo Kiviet

The Honourable Noxolo Kiviet is a member of the African National Congress (ANC) Party and became Minister of Public Service and Administration on 06 March 2023. She is the former Deputy Minister of Public Works and Infrastructure and was Premier of the Eastern Cape (2009 to 2014). She is a Member of the Parliament of the Republic of South Africa. The Minister has been very active in politics from an early stage. During the 1980's she held various positions in COSAS and later AZASO. It was due to her political activism that she was excluded from the University of Transkei, thereby being forced to seek employment, and immediately joined the labour movement. The period between 1996 and 2003 saw her serving in several strategic positions in the African National Congress (ANC), including as ANC Whip. Previously, she was elected to the PEC as Provincial Treasurer of the ANC for two consecutive terms, offering much-needed financial management expertise to the organization. She previously served as Cosatu Gender convener (1994-1997) and as a representative of labour in NEDLAC in the Finance and Fiscal Chamber until 1997, when she was elected as a public representative and joined the Eastern Cape Provincial Legislature as a Member. From 2003 to 2004, she was deployed as the Chairperson of the Portfolio Committee in the Office of the Premier and was a member of the following Committees: Finance and Provincial Expenditure; Economic Affairs; Youth, Gender, and People with Disabilities; SCOPA and Member of the Advisory Board. It was during her term as Premier of the Eastern Cape Province (2009 to 2014) that the Eastern Cape saw the implementation of massive investments for the social and economic infrastructure of unprecedented proportions. Minister Kieviet is the former speaker of the Eastern Cape Provincial Legislature (2014-2019), a position she also held from 2004 to 2009. In December 2017, she was elected to serve as an ANC Member of the National Executive Committee (NEC). As education has remained her passion, during her working career, in 2006, she enrolled to further her academic skills. This saw her completing an Advanced Public Administration Certificate Honours Degree and in 2010 graduated with a Master's degree in public administration from the University of Fort Hare. In 2018, the Rhodes Business School awarded her a PRE-PHD certificate in Business and Management Research after she successfully completed the PRE-PHD Workshop, thus allowing her to enrol for a Doctorate Degree.

She is an expert in anti-corruption law, public procurement law and policy in Africa; procurement in the multilateral development banks; gender-responsive procurement; emergency contracting; sustainable public procurement and blockchain technologies. She has written/edited several books and authored over 60 peer-reviewed publications. She co-developed and teaches on the LLM and PGDip in Public Procurement Regulation and Policy at Stellenbosch University, the first if its kind in Africa. She has been globally recognised for her research and in 2019, she obtained her first NRF rating in the B2 category. In December 2022, she was awarded the prestigious International Anti-Corruption Excellence Award for Academic Research and Education by the United Nations Office on Drugs and Crime (UNODC) and the State of Qatar. In 2021 she was designated by the Open Contracting Partnership (USA) as an "anti-corruption champion." She has received Stellenbosch University's Research Excellence Award twice- in 2014 and 2019. In 2020 she was also appointed as a research fellow by the Public Procurement Research Group in the University of Nottingham, UK. Her research was cited by the South African Constitutional Court in the case of Shaik v The State (2008), in which corruption allegations were levelled against President Jacob Zuma. She is involved in academic and policy oriented research and has drafted some significant policy and research reports, for international organizations, such as for Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, (South Africa, 2024); for the International Development Research Centre (Canada, 2023 & 2024); for UN Women (South Africa, 2023); for Global Integrity (USA, 2022); for the Open Contracting Partnership (USA, 2021); for the United Nations Economic Commission for Africa (Ethiopia, 2017); for the European Union and United Nations Office on Drugs and Crime (Nigeria, 2015) and for the Organization for Economic Cooperation and Development (France, 2011). She is a regular keynote and conference speaker and has spoken at over 120 international events in over 35 countries. As an expert on anti-corruption law and policy, she developed anti-corruption courses for the UN Virtual School in 2012 and the UNODC in 2019. She served on the World Bank's Procurement Technical Advisory Group from 2008- 2011, created to advise the World Bank on its procurement policy. She has an LLM (with distinction) from the London School of Economics (2000), and a PhD in public procurement and anti-corruption law from the University of Nottingham, UK (2011). She has worked at the universities of Stirling and Nottingham, both in the UK, and the University of Lagos in Nigeria.
