

The Centre for Medical Ethics and Law, Faculty of Medicine and Health Sciences, Stellenbosch University highlights the Department of Medicine's activities from January to June 2023

During the first half of 2023, the Centre for Medical Ethics and Law completed its undergraduate teaching for first, second, and fifth-year students. Undergraduate teaching and learning began with the renewed curriculum for 294 second-year medical students, followed by 290 first-year students and a 3-week fifth-year Ethics module for 309 students. Postgraduate teaching occurred in person at the Tygerberg campus and was attended by all current PhD candidates. All doctoral candidates have been intensely engaged in their research in Uganda, Malawi, Botswana, Zambia and South Africa.

The third edition of the prescribed ethics textbook for medical students, edited by Professor Keymanthri Moodley "Medical Ethics, Law and Human Rights: A South African Perspective, " is now available. The Centre has participated in seminars, conferences, and discussions, some of which are highlighted below:

ARESA PhD students - 16 - 18 January 2023

The ARESA Bioethics leadership program's PhD candidates participated in a writing retreat anchored by Prof Shenuka Singh. In addition, the candidates were introduced to Dr. Liela Groenewald (Head of the Doctoral Office), who gave a brief overview of the role of the doctoral office.



Upon completion, the candidates attended a two-week African Doctoral Academy course hosted in Stellenbosch.

Prof Ochieng's presentation at the 14th International Congress of Human Genetics **Conference - 22 - 26 February 2023**

Prof Ochieng, a PhD candidate on the ARESA Leadership Program, gave a poster presentation entitled: 'Feedback of Individual Genetic and Genomics Research Results: A Qualitative Study Involving Grassroots Communities in Uganda' at the 14th International Congress of Human Genetics Conference held in Cape Town. He is supervised by Prof Moodley and Prof Marlo Moller.



Undergraduate Teaching and Learning: MBChB I, II, and V Ethics Module —

MBChB I renewed curriculum - 20 - 24 February 2023

The Centre presented the ethics module to 290 first-year students under the renewed curriculum in February 2023. The module was held over one week, which began with self-study and comprised teaching by internal and invited lecturers. The assessment was via an electronic quiz on SUNLearn.

MBChB II renewed curriculum - 31 January 2023

In January 2023, the Centre successfully presented the ethics module to 289 second-year medical students under the renewed MBChB curriculum.

In March 2023, a successful ethics module was presented to 307 fifth-year medical students by the Centre. The module duration was three weeks and included synchronous

lectures, small group discussions, group assignments, and student presentations. Prof Kevin Behrens from the Steve Biko Centre for Bioethics at the University of Witwatersrand was an external examiner for the group assignment presentations. Prof Behrens praised the undergraduate students for their ability to apply their theoretical knowledge to real-world ethical



dilemmas in clinical care and expressed his satisfaction with their level of ethics engagement. 2023 marked the 20th anniversary of this Ethics Module.

Medical Protection Society (MPS) student debate - 24 March 2023



The Centre for Medical Ethics and Law, in collaboration with the Medical Protection Society (MPS) and the Tygerberg Debating Union, hosted a robust Ethics Debate with the motion: This house would impose penalties for medical institutions that do not attempt to reduce their environmental impact.

Dr Chad Beyer adjudicated the debate amongst medical students. The proposition team members were Destinee Bombil, Lesedi Motumi, Joy Adewumi and the opposition members were Tumisang Monau, RebaOne Methola and Sana Moodley

Both teams presented thought-provoking arguments regarding the impact of climate change and the responsibilities of healthcare institutions. Professor Moodley and Dr. Behrman presented trophies and vouchers to the team members.

7th Bioethics Society of Kenya Conference - 9 - 10th March 2023



Prof Moodley was invited to deliver the keynote address at the 7th Bioethics Society of Kenya Conference, which took place in Nairobi, Kenya. The conference theme was "Bioethics in Africa: Prospects and Challenges."

World Health Organization (WHO) Collaborating Centres meeting - 6 &7 June 2023



Prof Moodley attended the 14th Annual Meeting of the Global Network of WHO Collaborating Centres for Bioethics which was held in Rome, Italy. The Centre for Medical Ethics and Law has been redesignated as a CC for the third time and remains the only CC in Bioethics in Africa.
