PROCEDURE AND REGULATIONS REGARDING SUBMITTING AN INTERNAL LETTER OF INTENT TO INFORM GMO OF THE INTENTION TO APPLY FOR INTERNATIONAL FUNDING

SCOPE: This document applies to all Stellenbosch University (SU) Faculty of Medicine and Health Sciences (FMHS) researchers submitting proposals for international sponsored projects (grants), including subcontract proposals.

BACKGROUND AND REASON FOR THE REGULATION: Researchers of the SU FMHS apply for research funding through international sponsored programs. Submitting the best proposal possible is in the best interest of all parties involved. Early engagement of the GMO allows Principal Investigators (PIs) to submit proposals of the highest quality and with the highest probability of success. An Internal Letter of Intent (ILOI) is required to enable GMO to plan for assistance and to identify potential overlapping of projects.

RESPONSIBILITIES

- 1. The GMO is responsible for developing and communicating this procedure to the FMHS research community and PIs.
- 2. All SU FHMS departments, divisions, units or centers submitting international sponsored proposals are responsible to comply with this regulation.
- 3. The PIs are responsible for submitting an ILOI to the GMO as soon as he/she decides to apply for international funding.
- 4. The Head of the Department must be aware of the application, and together with the PI, must sign the ILOI and must be willing to arrange for a scientific review of the application.

PROCEDURE

- 1. Pls must be eligible to apply for an international award.
- 2. Pls planning to submit a research proposal for **international funding** must send an **Internal Letter of Intent (ILOI)** to the GMO **not later than 60 days** before the application due date of the sponsor, allow for adequate internal scientific review by peers.
- 3. The PI informs the GMO with the ILOI by email (addressed to the GMO manager, Mr Eugene Baugaard eugeneb@sun.ac.za and Dr Christa de Vries cdevries@sun.ac.za of the intent to apply for the sponsored project.
- 4. In the subject line of the email, add the following information: Intent to apply for grant: PI Name, Sponsor, and Application Type. *Eg. Intent to apply for grant: J Jacobs, NIH, R01*
- 5. Attach a one (1) page ILOI, containing the following information, to the email:
 - Sponsor Name, Number of the Notice of Funding Opportunity (NOFO),
 - The sponsor's application due date
 - Preliminary Title (not more than 200 characters)
 - Specific Aims
 - List of Key Personnel (KP)
 - List of collaborating institutions and contact persons
 - Name & signature of the PI and Name & signature of the Head of Department
- 6. The GMO will follow a "first-come, first-served" protocol for all proposal submissions.
- 7. Vice Dean of Research of SU FMHS reserves the right to retract any proposal submitted by individuals who lack substantive preliminary specific aims.
