The following points were on the agenda:

1. Opening and Welcoming:

 The Speaker of the House opened the meeting by officially welcoming all members of the committee.

2. Presentation by Dr Nel: Increasing Female Space in Stellenbosch University Residence

- Proposal for the 60/40 female and male representativity in the Stellenbosch University residence is due to the enrolment and registration statistics that have been witnessed.
- A working group has been appointed to determine the feasibility of implementing coed in university's residences.

3. Backlash Directed to Student Leaders:

- SRC Policy Officer mentioned that the student leaders were anticipating a backlash from the student body due to this proposal.
- Dr Choice responded by saying that the student leaders will get support from management in case of any backlash and emphasized that the university are still open for suggestions as nothing has been formalized yet. She further elaborated that the university is going to receive a further 400 beds and they have not decided on the utilization of these beds.

4. Timing of the Announcement:

- The President of Helderberg Men's Res and Chris Briel questioned the timing of the announcement. They mentioned that the management started talking about it in December when they realized that the statistics trends since 2017 but they are only making the announcement two weeks prior to the exams.
- Dr Choice responded by saying that the impact of Covid-19 has also caused these unprecedented trends and the university was waiting to complete the welcoming period to confirm that the trend still continues thus the late announcement to the coed consideration.

5. Public Participation:

- The Deputy Speaker of Student Parliament enquired about the efforts that will be made to consult the residence students.
- Dr Choice responded by saying that public participation will be conducted on a broad spectrum and further mentioned that there is no deadline for public participation thus it is still ongoing.

6. The Involvement of Council:

- Bernard Oosthuissen enquired whether or not Council will have to approve the co-ed in the university's residence.
- Dr Choice responded by saying that Council is a government structure thus it will be informed, advised and given feedback frequently on the matter as it has public interest.

7. Safety Considerations:

- Miss Risuna Risimati enquired about the safety measures that will be implemented to avoid GBV when females move into male accommodations.
- Dr Choice responded by saying that GBV is a serious issue and when the decision for co-ed is being made safety measures will be taken into consideration too.
